Attach this unit to the rear side of Xperia and combine it with a tripod, etc. to shoot selfies with the main camera of Xperia.

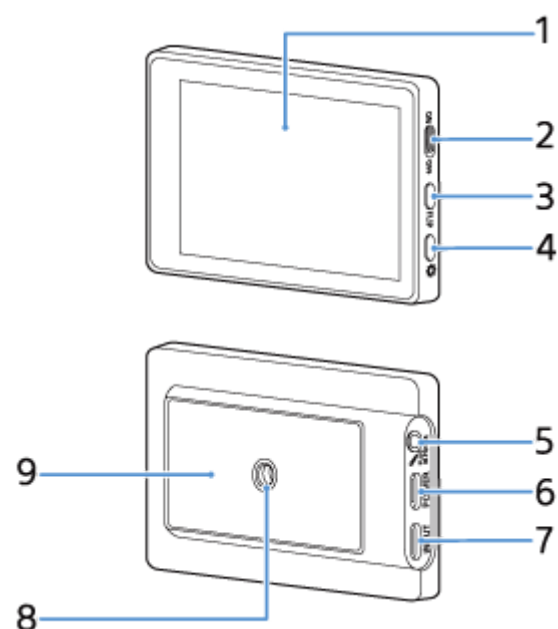

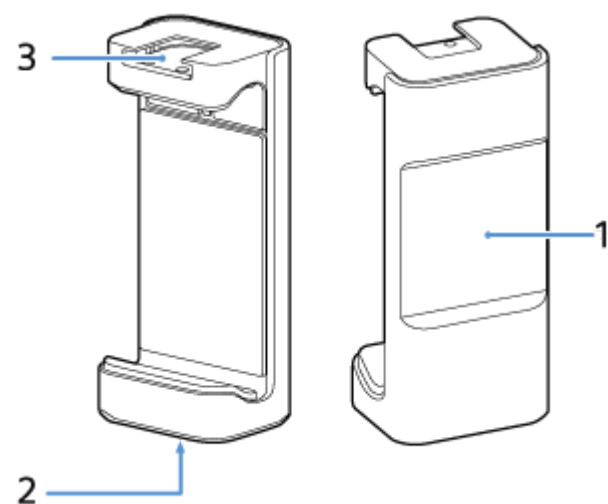
## Identifying the parts

### Monitor



1. LCD screen (size: 3.5-inch / resolution: 1280 × 720)
2. ON/OFF (Screen ON/OFF) switch
3. FLIP (Screen flip) button
4. ⚙️ (Brightness control) button
5. 🎤 Microphone jack
6. POWER (Charging) port
7. INPUT (Input) port
8. Tripod socket hole
9. Holder attaching area

### Holder



1. Magnet for attaching monitor
2. Tripod socket hole
3. Accessory shoe

## Connection cable

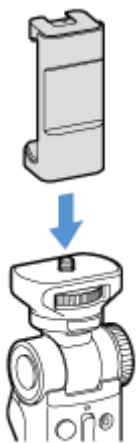

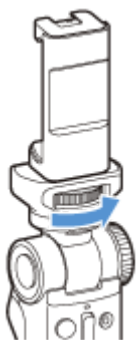
## Attaching a grip

Attach a grip with a camera mounting screw.

- 1 Insert the camera mounting screw of the grip into the tripod socket hole of the holder.



- 2 Turn the camera mounting wheel of the grip to secure the holder.

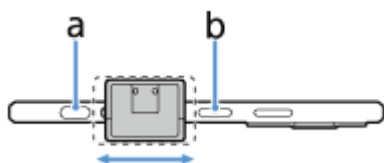


### Note

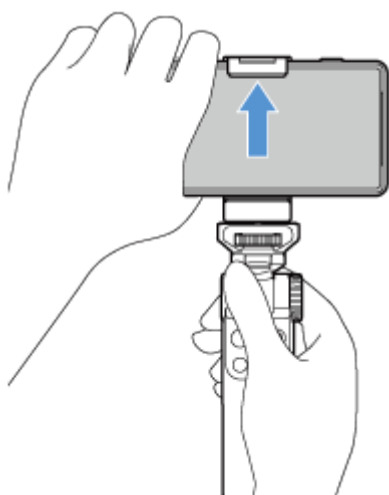
- Use a tripod with a screw shorter than 5.5 mm. The holder cannot be fixed firmly to a tripod with a screw that is 5.5 mm or longer, causing damage to this unit.

## Attaching a smartphone

- 1 Position the holder between the camera key (a) and the power key (b) of the smartphone.

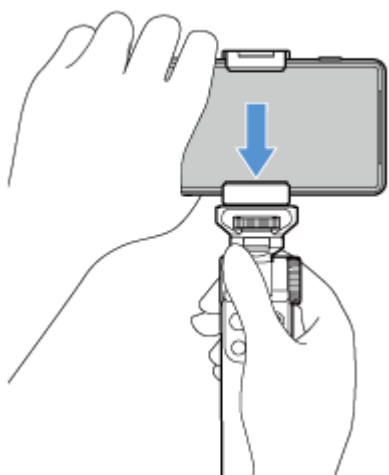


- 2 Put the smartphone on the top of the holder.



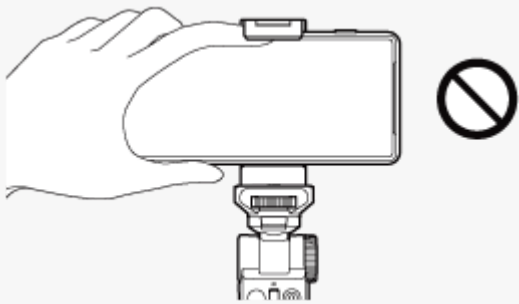
- 3 Fit the smartphone to the bottom of the holder.

Firmly set the smartphone so there are no gaps between the holder and the smartphone.



### Note

- Be careful not to pinch your finger between the holder and the smartphone. It may cause bodily injury.



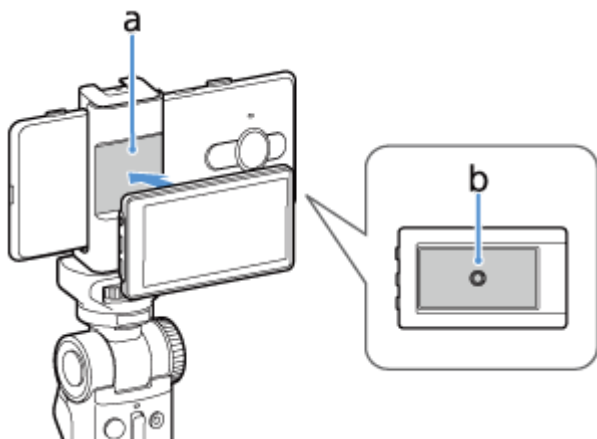
- Carefully attach the smartphone to avoid making scratches.

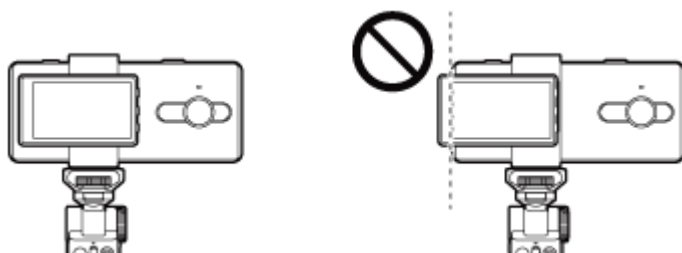


## Attaching the monitor

- 1 Combine the magnet of the holder (a) and the holder attaching area of the monitor (b) to attach the monitor in a well-fitting manner.



- 2 Adjust the monitor position.



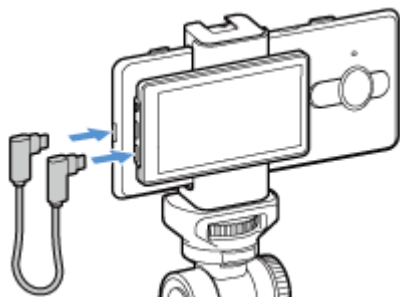
- Check that the monitor does not cover the smartphone camera.
- Do not let the left side of the monitor stick out of the smartphone. It may cause communication disturbance.

### Note

- Attaching the monitor improperly may cause the monitor to drop, resulting in bodily injury or malfunction of this unit.

## Connecting a smartphone

---



- 1** Connect one end of the connection cable supplied to this unit to the smartphone.
- 2** Connect the other end of the connection cable to the INPUT (Input) port of the monitor.

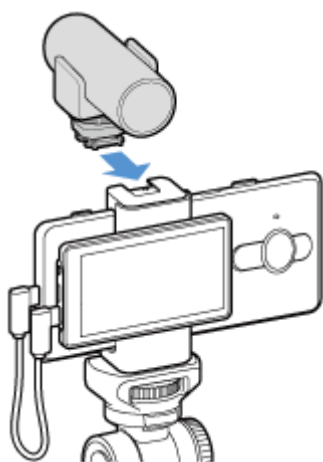
### Note

- If you disconnect the connection cable when shooting, shooting will be stopped. At this time, a message may appear on the smartphone for reconnecting of this unit. Follow the instructions.
- We cannot guarantee the performance if you use a cable other than the connection cable supplied with this unit. Always use the supplied connection cable.
- When the connection cable is connected, the monitor flashes for a moment due to energization. It is not malfunction.

## Attaching a microphone

You can attach a microphone to the accessory shoe of this unit. Please also refer to your microphone manual.

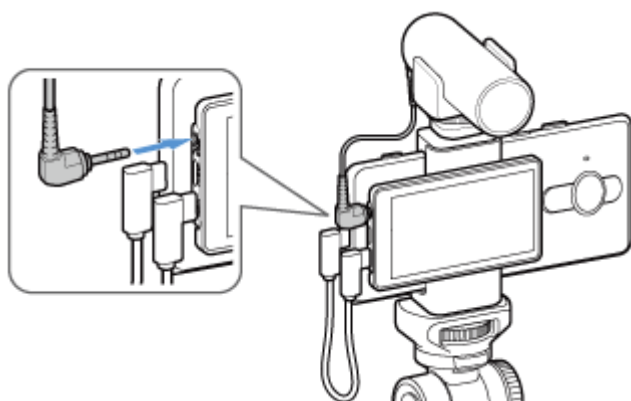
- 1 Align the foot of the microphone with the accessory shoe on the holder and attach the microphone.




- 2 Rotate the lock knob of the microphone to secure the microphone to the holder.



- 3 Connect the microphone to the  microphone jack of the monitor with the connecting cable supplied to the microphone.



### Hint

- The internal microphone of the smartphone is automatically switched to the external microphone when a microphone is connected to the  microphone jack of the monitor of this unit.

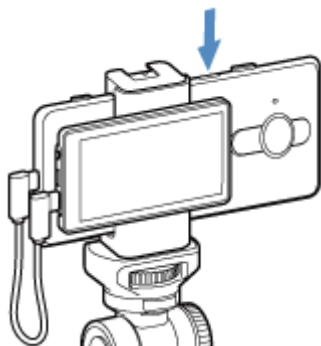
- Connect the microphone before launching the app.

## Shooting

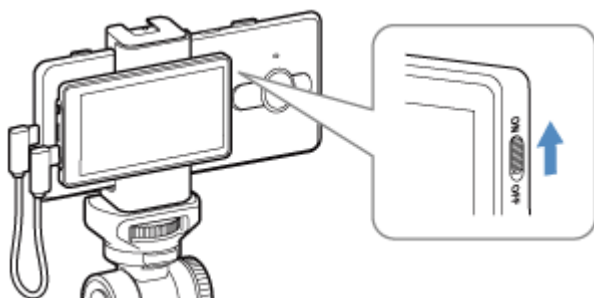
- 1 Turn on the power of the smartphone and launch a compatible app.

Example: Photography Pro, Videography Pro



- 2 Turn the ON/OFF (Screen ON/OFF) switch to "ON".

A camera image is output from the smartphone to the LCD screen of this unit.




### To flip the screen

Press the FLIP (Screen flip) button.

The screen orientation changes as follows each time the button is pressed.

Mirrored → Real → Real, Upside down → Mirrored, Upside down

### To adjust the brightness

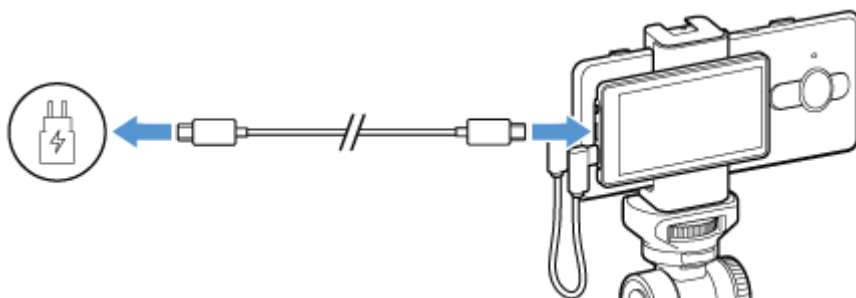
Press the  (Brightness control) button.

The brightness changes as follows each time the button is pressed.

High → Boost → Low → Mid

## Shooting while charging a smartphone

You can shoot while charging the smartphone connected to this unit using a USB cable for charging smartphones.



- 1 **Connect this unit to a smartphone.**
- 2 **Connect one end of a USB cable to the USB port of a charger.**
- 3 **Plug the charger into a power outlet.**
- 4 **Connect the other end of the USB cable to the POWER (charging) port of this unit.**

### Note

- If you disconnect the USB cable when shooting while charging, shooting will be stopped. At this time, a message may appear on the smartphone for reconnecting of this unit. Follow the instructions.
- If the smartphone is turned off, it cannot be charged through this unit.
- Do not leave the smartphone connected to this unit and charger while it is turned off. It may cause the smartphone to malfunction.
- Always use the following original Sony charger and USB cable since other types of chargers can increase charging time, not charge at all, or may even damage your device.
  - The charger and the cable supplied to the Xperia model that is compatible with this unit
  - Sony Fast Charger XQZ-UC1 (DC5.0V / 3.0A) and USB Cable
- The INPUT port and POWER port of this unit are USB Type-C®.
- Always use the supplied connection cable to connect this unit to a smartphone. We cannot guarantee the performance if you use a cable other than the connection cable supplied with this unit.
- When you connect a charger to this unit, power is supplied from the POWER port through to the INPUT port, then to the smartphone.
- The output rating value from the INPUT port of this unit to the smartphone is DC5.0V / 2.6A.
